

**FESTES DEL ROSER**  
**EL TRIANGLE**  
**Legal Bases**

**FIRST. - ORGANIZING ENTITY**

The Association of Merchants of the El Triangle Shopping Center (hereinafter, "El Triangle"), with VAT number V61851234 and its registered office at Plaça Catalunya, number 1, 08002 Barcelona, organizes the action described below on the dates indicated, aimed at the users of the El Triangle Shopping Center, in accordance with the instructions outlined in these legal bases.

**SECOND. - SWEEPSTAKES BASES**

**I.- Personal Scope:**

All individuals who meet the participation requirements set forth in these legal bases are eligible to participate in this action.

**II.- Temporal Scope:**

The promotion will take place from October 6 to 11, 2025, from 4:00 p.m. to 8:00 p.m. on all the days mentioned above (hereinafter, the "Period"). The promotion will end on October 11 at 8:00 p.m. or while supplies last.

**III.- Access to the promotion and participation:**

To participate in the event, which will be governed by the conditions set out in these rules, participants must show a purchase receipt from any store in El Triangle Shopping Center corresponding to a purchase made during the event days, submit the voucher provided by the hostesses at the LUSHÉ store located in the same shopping center (Carrer Pelai), and comply with the requirements established in Clause Three of these legal rules.

**THIRD. - PARTICIPATION MECHANICS**

To participate in the event, which will be governed by the conditions set out in these rules, participants must show a purchase receipt from any store in El Triangle Shopping Center to the hostesses located in the center, with no minimum amount, which will be stamped by them. Once completed, a voucher will be issued per person and day, valid while supplies last or until Saturday, October 11, 2025, at 8:00 p.m., which can be redeemed for a classic Cinnamon Roll of the size specified by the organization at the LUSHÉ store located in the same shopping center.

**FOURTH. - ACTION MECHANICS**

All participants who follow all the steps of the participation mechanics described in Clause Three of these legal bases have the chance to participate in the Roser Festivities action.

#### **FIFTH. - PRIZE DELIVERY**

At the moment of participating in the promotion and meeting all requirements, the participant will receive a voucher to go to the LUSHÉ store and claim their prize.

#### **SIXTH. - PRIZE**

Users who meet all requirements will receive a voucher to claim a free classic Cinnamon Roll at the LUSHÉ store in El Triangle. Quantities are limited, with a maximum of 500 Cinnamon Rolls to be distributed. The promotion will be valid until October 11 or while supplies last, whichever comes first.
