Legal Terms & Conditions**

FIRST. – ORGANIZING ENTITY

The Association of Shopkeepers of the El Triangle Shopping Center (hereinafter, "El Triangle"), with CIF number V61851234 and registered office at Plaça Catalunya, nº 1, 08002 Barcelona, organizes, on the dates indicated below, a giveaway addressed to users of the El Triangle Shopping Center's Instagram digital platform, in accordance with the instructions detailed in these terms and conditions.

SECOND. – GIVEAWAY RULES

I. – Personal scope:

All individuals who meet the participation requirements set forth in these legal terms are eligible to participate in this campaign.

II. – Timeframe:

The campaign will take place from July 1 to July 13, 2025, with the latter being the last day to participate. The final draw will take place on July 14, 2025 (hereinafter, the "Term"). El Triangle will contact the winner on July 14, 2025, via email or direct message on Instagram.

III. – Access and participation:

To enter the giveaway conducted under these terms, participants must: follow the Instagram profile @eltriangle, like the giveaway post, and complete the giveaway's web form, which can be accessed via the Instagram bio link or directly on El Triangle's official website.

THIRD. – PARTICIPATION MECHANICS

To participate in the giveaway, users must follow the @eltriangleInstagram profile, like the giveaway post, and fill in the corresponding web form.

Completing all the required steps will grant access to the draw for one of two €100 gift cards, valid for purchases at El Triangle Shopping Centre.

El Triangle will then contact the winner via email and/or direct message on Instagram on July 14, 2025.

FOURTH. – ACTION MECHANICS

All participants who complete all the steps described in Clause Three of these legal terms and conditions will be eligible to enter the draw for two gift cards worth €100 each, to be used for purchases at El Triangle Shopping Centre. There will be two different winners.

The Shopping Center Management will hand over the two gift card in person at the reception of El Triangle.

FIFTH. – WINNER ANNOUNCEMENT AND PRIZE DELIVERY

On July 14, 2025, the name of the winners will be announced through Instagram Stories.

Winners will have two (2) calendar days to respond to the message and provide the necessary information to coordinate the prize collection at El Triangle's reception.

Otherwise, the winner will forfeit their right to the prize, and El Triangle may decide to (i) withhold the prize or (ii) appoint another winner from among the eligible participants.

SIXTH. – PRIZE
